Thanks to Carol Anne Deneka and our fundraising committee for the hard work in organizing events such as the golf tournament and donor campaigns.


And lastly, thanks to our donors, volunteers, facilitators and board members, whose hard work and dedication make LCCJ a successful agency.


### Report from the Executive Director, Joellen McHard

## Highlights for 2022-2023:


### 1) Youth and Adult Community Justice Diversion Programs Activities:

- Restarted the before youth court meetings that used to happen pre-covid, to triage referrals with the Crown Attorney and other Justice Service Providers
- Worked with RNJ Youth Services and justice partners to streamline the referral process and develop a memorandum of understanding
- Transitioned to offering forums in person and hybrid as well as, on-line
- Held regular monthly volunteer facilitator meetings with quarterly guest speakers
- Many of the volunteers trained in 2021 moved from observer to co-facilitator or lead status
- We had one community referral from a not-for-profit agency
- Worked towards an On-Line Client Management System
- Maintained, revised, and analysed the database of LCCJ cases to show program effectiveness, to help understand our strengths and weaknesses and to support funding activities




# Pre-Police vs. Post-Crown







## **Youth Case Resolution**




# **Adult Case Resolution**

## 2) Restorative Practice within our Community

### **Activities:**

- a) Developed and delivered a social media campaign and communications to increase our community outreach
  - Please check out our 38 videos and 12 playlists on YouTube
  - 848 Followers on Facebook and 339 on Instagram, 86 Posts or 1.5 week.
  - 4 Interviews on Lake 88, two Ottawa Valley News Articles one about our Open House and one about Triple P Parenting
  - Updated Google Business Profile and joined Google for Non-Profits
- b) Strengthened partnerships with YAK Youth Service by co-locating to create Community Services Hub and strengthen partnerships with other agencies.
- c) Continued to partner with Family and Children Services of Lanark, Leeds and Grenville to deliver 3 Triple P Parenting of Teens sessions funded by the Perth and District Community Foundation and the County of Lanark
- d) Restorative Practice for Educators Series Sept 2022 to June 2023 10 months or 1.5 Hours of training was offered monthly, to educators on implementing restorative practice in schools, classrooms and with students. The training was delivered by Stephen Young, Author of the Restorative Principal, and Andrew Lynch, retired local Principal and Sheri Halladay. This training was offered to Educators in UCDSB and CDSBEO with funding from United Way East Ontario.

### Stephen Young: Steve is the author of The Restorative Principal.

<u>www.restorative.ca</u> He has been involved in the use of Restorative Practices in schools as a since 2002. He took the lead in his school board for the coordination of RP programs, organizing and delivering staff training, facilitating formal conferences, and educating the school community about RP. In 2015 he earned his master's degree in Restorative Practices from the IIRP Graduate School in Bethlehem Pennsylvania.

- c) Stephanie Corrine was hired to replace Sheri when she was on leave in April May 2022. Stephanie now works at The Table Community Food Foundation.



#### TRAINING AND EDUCATION:

Provided ongoing volunteer training and education to enhance skills

- a) Provided Trauma Informed Training funded by the Perth and District Community Foundation to staff, board, facilitators, and community partners for 30 people for two three-hour sessions. The trainer was Jennifer Slay from Waterloo, Crisis, and Trauma Resource Institute <u>www.ctrinstitute.com</u>.
- b) In recognition of the Department of Justice, Victims and Survivors of Crime Week we had a Volunteer Appreciation Dinner, Friday May 20th, 2022, with Guest Speaker Erin Lee from Lanark County Interval House speaking about the intersection of intimate partner violence and community justice work.
- c) Volunteers, staff and student attended the National Restorative Justice Consortium

#### **ORGANIZATIONAL DEVELOPMENT:**

- a) Strengthened governance, staffing and volunteer base considering equity, diversity, and inclusion (EDI)
  - Board recruitment targeting persons identifying as part of a minority groups

### **Report from the Treasurer, Barry Fisher**

The Corporation is in sound financial condition, despite showing a shortfall for the year. As explained further below, a change in our revenue recognition policy last year means that major funding received can only be recognized when the expenses of rendering the specified purpose for that funding are incurred. Additionally, this revenue recognition policy focused on differentiating between restricted and unrestricted contributions and only allows for the restricted revenues to be deferred for future use. This transition should bring revenue and associated

expenses better into alignment by the end of the Corporation's next fiscal year (2024), and we have developed a balanced budget for the fiscal year. Operating expenses are generally covered by non-specific purpose fundraising and donations, and when fundraising and donations decline, there are fewer funds to offset the costs. The Corporation has a good cash position and significant accumulated surplus to continue to achieve its objectives.

For the fiscal year ended March 31, 2023 (the "Current Fiscal Year") reported revenues decreased from \$208,859 for the same period ended March 31, 2022 (the "Previous Fiscal Year") to \$150,971. While Foundation grants remained solid, other sources showed declines, most notably in extraordinary grants received in the Previous Fiscal Year and not available in the Current Fiscal Year such as the Polar Bear Plunge (\$21,333) and Canada Wage Subsidy (COVID \$15,579). There was, as a result, a net excess of expenses over revenues of \$27,780, and a reduction of net assets from \$74,723 to \$46,943 from the Previous Fiscal year to the Current Fiscal Year.



There are two additional explanations for this apparent decline: 1) reporting transitioned in the Previous Fiscal Year to a more accurate approach for deferred revenue recognition, which resulted in the deferral of revenue until the services for which the contribution has been earmarked are performed. As explained in the Treasurer's Report for the Previous Fiscal Year, a substantial increase in reported fundraising revenue (\$5,489 to \$31,153) was "*due to successful fundraising for the next year*" (2023). This change in accounting methods required that earmarked revenue be recognized in the year it was received (2022), not the year in which the associated expenses were incurred (2023). The transition to this new accounting method should bring revenue and expenses into better alignment by the end of the next fiscal period (March 31, 2024; and 2) where funding is program-specific, the importance of non-specific funding from donation and general fundraising activities that covers general operating expenses as salaries and rent increases.

On the positive side, even with the deficiency, cash at year end declined only marginally, and together with accumulated surplus and internally restricted contingency, raised no ongoing risk concerns for the foreseeable future. While overall revenues were down in the Current Fiscal year, expenses were closely monitored and increased only slightly over the year despite increased activity and community presence.
